Subject: Update on GST rates and MRP on Hamdard's products and action points

The GST Council in its 56th meeting has announced GST rate revisions to be made effective from 22 September 2025. We commend and support the Government of India on this move to benefit the end consumers. To support this, it is essential that we along with our channel partners ensure that the benefit given by the government is passed on to the consumer.

Based on notification issued by government of India, GST rates on select products manufactured by Hamdard Foods India are proposed to be reduced from present 18% and 12% to 5%. Based on the proposed changes, we have annexed herewith the updated MRP on Hamdard's products that have undergone a change.

Below are the key action points which require are necessitated owing to the proposed GST rate changes.

- Effective 22nd September 2025 please ensure that the invoices raised for Hamdard Foods India's products carry the revised applicable GST rate.
- As per the GST law, it is mandatory to pass on the benefit of reduction in tax rates to the end
 customers. Therefore, we urge you to pass on the benefit of GST rate reduction to the retailers
 on invoices raised by you. We also request you to disseminate such instructions across your
 retailer network to ensure that benefit of GST rate reduction is extended to end consumers
 and final price charged is as per updated MRP as mentioned in the annexure.
- As per provisions of Legal Metrology Act and allied rules and guidance from the Department of Consumer Affairs, Government of India, all the stock are to be sold considering revised MRP from 22 September 2025. We request you to ensure that the products are sold strictly in accordance with the updated pricing to retailers and thereafter to the end consumers, in line with the regulatory requirements.
- With respect to inventory purchased at either 12% or 18% GST rate which need to be sold subsequently at a reduced GST rate of 5%, we wish to clarify that as per provisions of GST law, input tax credit on such inventory is available in full to you. In other words, your eligibility to claim the full input tax credit remains unchanged. Hence there shall be no loss of Input Tax Credit on this account.



We value your partnership and therefore hope you will comply with the aforementioned steps to ensure benefit of GST rate reduction is passed onto the end customers.
